Boat numbers will be assigned on the day of the tournament during the check-in. Check in and inspection will begin at 6:00 am at the ramp. All entries must be checked in and entry fees paid by 6:30 am. A pre-tournament meeting will be held at 6:45 am on the water. All state and local laws must be followed Mid-Ohio Bassmasters rules will also apply for weight in penalties etc..
